Thought I'd quickly check in on the DTC regulations package. I understand that the Reg Registry posting is closing Friday, so we are unlikely to have materials until Monday (please confirm). However, even if we don't have things on Monday the hope is that we send out a (LRC)-CBN at that time (please confirm that is possible).

As a reminder, because these items are tracking DTC, 90 copies of all materials are required for binder distribution, but I would also ask the ministry to send us final matching digitals as I would like to have those for LRC records (including your note).
