I hope you had a good break. I'll try to be in around 8 am tomorrow to help you transition back. I've left the three Cabinet/committee binders on your desk and a note pad with some points I thought would be worthwhile discussion.

Of note:

- Attendance:
 - SoC is away for Mon-Tue; Martha acting.
 - Bofoa is away for the next two weeks; William is overseeing her responsibilities.
 - Shamira is acting for the Deputy this week (Martha did the last)
 - Martha is in and out this week.
 - Jackie is off next week with Sam from ECO acting for her
- P's briefing is at 10 am. Both Martha and Shamira will be attending (mostly Martha's items, and Shamira will be at Cabinet)
 - Remaining decision: fast-track for agency TB/MBC submission.
- Key files for discussion (snippet, with supporting materials attached):
 - Cannabis. Deputy is chairing a new Steering Committee (see **attached**, Martha's team has latest version). Few DM and Minister's meetings next week and first Steering Committee meeting the week of July 31st. Selection of new SMG2 underway (went to EDC last Friday).
 - The North. In response to an increase in youth suicides, Ontario is developing a new Secretariat (see **attached** draft news releases). Would be reporting to SoC. Selection of SMG2 to lead is underway (went to EDC Friday).
 - Seniors Strategy. Joint Deputy memo went out and session held, also discussed at DMC (see **attached**).
 - LTEP. Lots of meetings on this issue so see calendar; but note first part going to CAB this week and part 2 later.
 - Excellence for the Whole Child (previously "Well-Being"). Deputy met with DM Rodrigues to discuss options, including impact on grade 3 EQAO (see **attached**). Tamara working with ministry on scope of new information as confirmed approach with PO.
 - Basic income. Some concern on enrolment initially; monitoring with updated marketing/employment strategy underway.
- Corporate:
 - Q1 (phases 1 & 2) signed off and submitted. Hard copy on your desk.
 - MJEP. Discussed at PD-DMC with some concerns noted by others; individual submissions due last Friday. ECO submitted substantive feedback through HR.
 - ARD workplan developed and presented to MO and PO (DM reviewed – **attached**).
 - DM Zegarac's office requested monthly mtgs with the Deputy to discuss key FPT and Infrastructure files. Jackie setting up.

- POCO mtg items **attached**. 6 month list/priorities tabled with PO, but need to come back in August to finalize.
- Latest MYAP priorities document **attached** (with divisions for updating)
