I've spoken with Ed (who has spoken with Andrew) and Gale about our press release and on that basis propose the following key points for the release:

- * We are very pleased with this development
- * It represents a key milestone towards a comprehensive restructuring of USSC
- * The Province has been working hard with various stakeholders to help arrive at a positive outcome from this restructuring and views the news of an agreement between USS and Bedrock as very helpful
- * As a province, we will be prepared to provide necessary releases to USS as part of a comprehensive agreement on certain conditions, including satisfactory financial assurances with respect to the environment.
- * There are other conditions to the conclusion of a restructuring arrangement including agreements with certain key stakeholders
- * The details of these remain confidential and will be made public at a later date as part of the Court process.

Note that we are only referencing the environmental release above although we would also have to be prepared to

provide a pension release. However the environmental release is wholly ours whereas the pension releases involve multiple parties including the Union and Salarieds.

Ed is prepared to do any background briefing with media later today.
