Slide 31 and first slide 40: strikeout references to natural gas bill

It's one thing for us to re-run the modeling, it's another thing entirely to remove all reference to natural gas price pressure owing to cap and trade. The Budget published a table that spoke to the cost increase for home heating and for petrol at the pumps. So those are for sure comments that we are not going to accept (ie. not going to delete the strike through). Don't want to be difficult, but there comes a point where we start to lack some credibility.

The other stuff is interesting, Ministry staff doing a churn, especially on the minute, since we had not anticipated further edits to that; but in principle the above is the only thing that I'm reacting to at the moment.
