Just wanted to make sure you had the same material that I've shared with TBS and CO – in terms of next steps on the Doc Initiatives process. Its possible that its been shared with Steven and Helen.

We met with Brigid twice today and she is reaching out to Michelle Baker on the attached package. You'll notice we narrowed down the memo to be only "generic" in nature, and that Brigid and my name are added as contacts for process info. Brigid told us that Ali only wanted the memo to come from you and him, so we've updated for that too – everyone else is cc'ed.

This is the one of the items that we would discuss at a replacement meeting for FPC lite tomorrow (along with maybe a PER catch-up). I know PO is keen to get the memo out by end of week (although you'll notice that the list of ministries who would get this is pretty short).

Attached please find:

- Updated Policy and Fiscal Tracker (note we've shaded the lines we feel are candidates for a "memo" as per the PO direction yesterday);
- A draft updated memo that would go to ministries who are on the list of items that the PO would like work to begin (shaded rows above);
- A draft template we would provide to ministries who self-identify (following the Joint Chiefs\DM meeting next Tuesday) to outline the initiative they are working on that isn't yet being tracked; and
- The decision roadmap, which now has a slide 2 to show how we would operationalize the new process (including memo and joint Chiefs/DM meeting and direction).
