To support the objectives of the DM briefing tomorrow, please find attached:

- Draft Feb 6th LRC agenda released last Friday
 - Consistent with the leg items tracking on the Feb 8th Cabinet agenda; however, note that the TB/MBC decision for the Corrections legislation is still TBC
 - Agenda not locked down yet as final materials are due Thursday and publication is next Tuesday; leg variances are still TBC
 - Other than leg items, suggest DM be aware of Tab 3 (Hiring Practices) given history, Tab 6 (Winery/Distiller Permission) given potential PO/GHLO interest, and Tab 7 (OESP) given it is Energy.
- (not attached) The first draft of the Feb 20th LRC agenda will be released on Friday
 - Expected to be very busy; though only a few leg pieces expected for Doc that would track to Cabinet on Feb 21 or 28
 - Potential item(s) of interest relate to Cannabis
- Latest draft Leg Planning Tracker
 - Current status which reflects discussion from last week's leg planning meeting
 - PO indicated Doc items could go to Feb 20th LRC, if required
 - Next leg planning meeting planned for Feb 9th
