Attached is an updated minute that incorporates the version received from energy last night as well as SoC comments and Steven's comments this morning. We have incorporated most of the detail energy included but not in all areas, for example some of the detail on legislative change isn't here and some detail is more appropriate for a TB minute (e.g., on the affordability fund). I have left one comment in, around whether OEFC or the OFA would require any expanded powers as it could be added in 2Ai, will leave that to MOF to answer.
