## Major Accomplishments from January 1<sup>st</sup> to June 1<sup>st</sup> 2017:

**129** approved regulations (amending or new)

**1188** orders in council (51 were non-appointment through LRC)

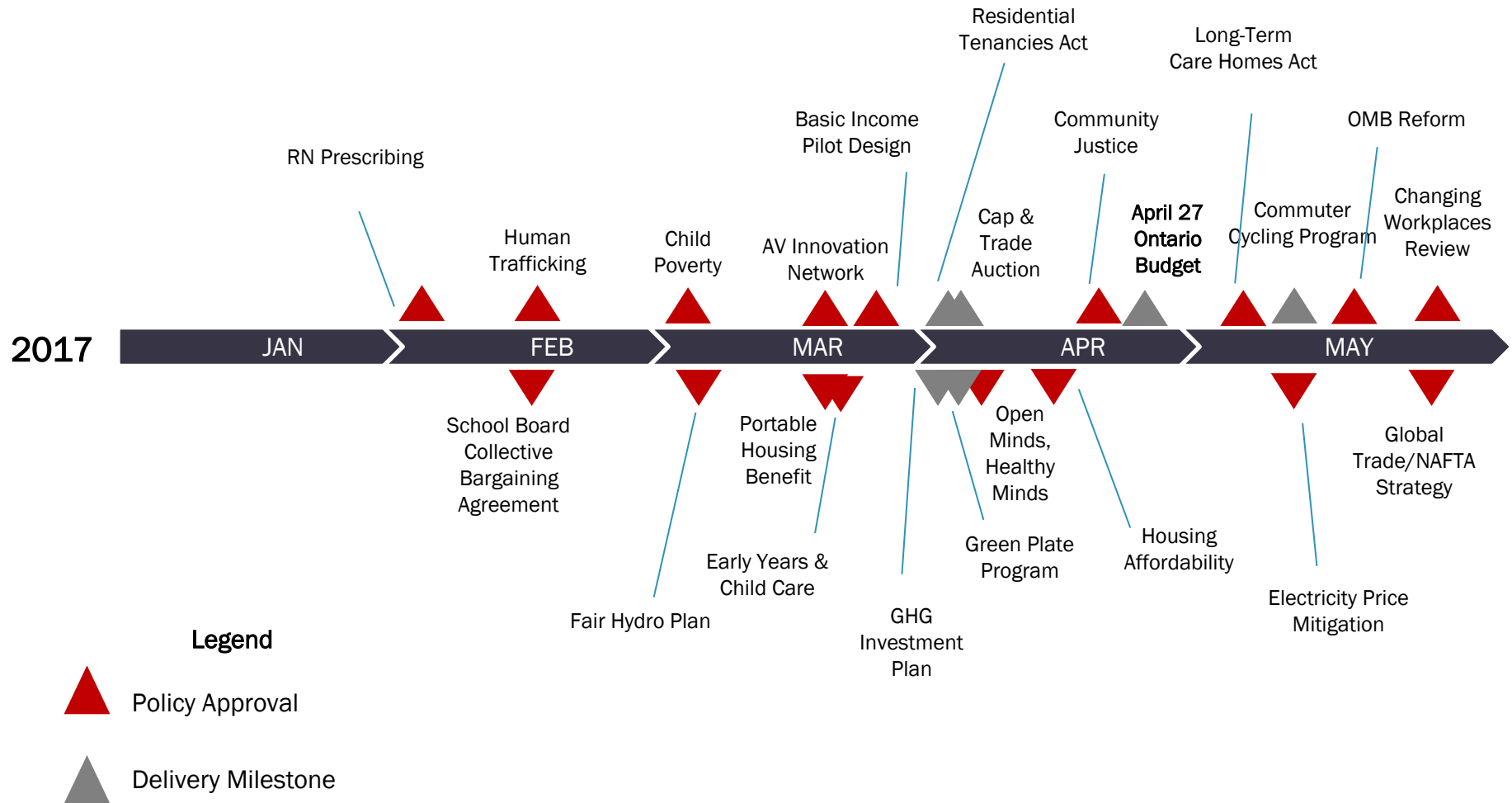
**12** bills introduced in Spring 2017, with 3 in House

**17** bills passed/received royal assent (just shy of record-breaking 18 bills)

\*Bill 89 is one of the largest government bills ever

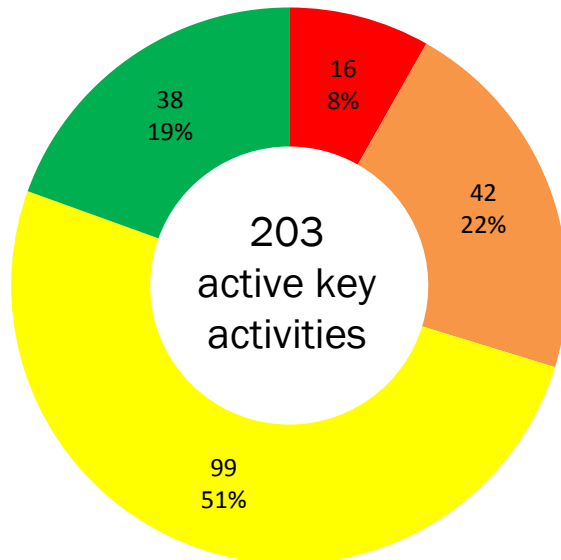

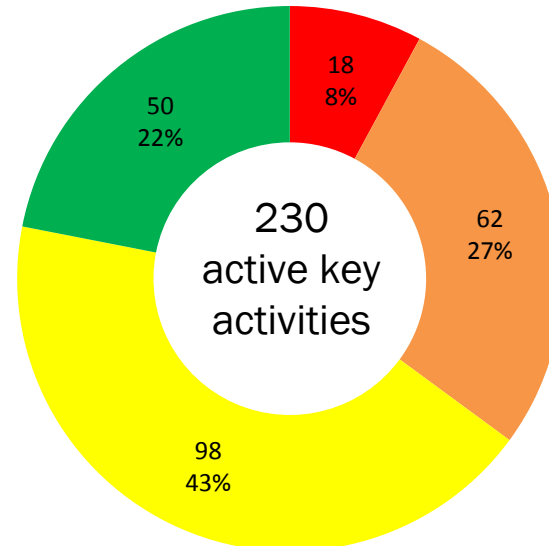
