Martha,

Here's the merged minute – it includes tracked changes and my comments. In summary:

- ENERGY's minute had a lot of detail about the OPG next steps – my sense is that this detail would be deferred to the March report back on the GA smoothing mechanism.
- The RRRP approval is still a bit confusing (we don't have a good description that particular group of consumers). I think the combined minute gets us closer, but could use your eyes on it.
- There are also program design details (eg LDC fund) in the ENERGY minute – I've removed these (TB decisions).

If you switch views to look at the final, you'll see the ENERGY additions in blue text. This may be a way to show ENERGY the merged minute with their language included.

It would be great to get a TBS read of this minute before we send back to ENERGY. Over to you!
