Slide 7 : add more context in those sub-bullets about how the revision upward is to bring the RRRP sum to be fully consistent with the SFT / Government Communications lines since mid September.

Slide 7 : "about 0.60\$ for average residential customer per month". Re: "about" - what is exact sum, please?

Slide 8 : sub-bullet call out " ... has not increase SINCE 200X, while rates..." (cut "over time").

Slide 14 : first bullet. Remove parenthetical note "(such as..)"

Slide 15 : "Portals". Need to add context that these are not SAMS-like, customer-facing, Hydro One CIS software boondoggles waiting to happen. It's basically an intranet between IESO» MEU's and Ministry» LDC's for the purposes of information sharing and program implementation, right? Need to add that sort of context, please.
