Hi Martin,

Hoping you can kindly please provide some additional details on the proposed regulatory bundle including:

- Please confirm: ENERGY is proposing amendments to two regulations (O. Reg 429/04 and O. Reg 196/17) and to develop a new regulation under the OFHP. Amendments would establish a methodology for the calculation of OPG management fees and of the role of the Ontario Energy Board (OEB) in reviewing those fees as well as a mechanism to recover fees and carry costs for the period from July 1, 2017 to April 30, 2021. Regulations are required for OPG to go to market to finance the debt from GA cost deferral.
 - o Earlier you stated there were 4 regulations that would be part of the bundle. Is there another regulation that would be amended or created in addition to the three stated above?
- Please advise: On the timing for when OPG is going to market, why OPG is tracking to those timelines, and how these timelines relate to the overall key steps for the delivery of this initiative.

Hoping you can kindly provide responses by the end of the day today if possible. Apologies for the tight timelines.
