Attached is an updated draft briefing note for TB/MBC on Monday. Cap and trade minutes updated to reflect MOECC and CO input. The Financial Summary table future year numbers have moved back to the numbers used at Chair's briefing, in consultation with Energy (there's a minute explicitly saying Energy will through the upcoming PRRT process update the outyear numbers). The \$300M for 2016-17 remains and aligns with the signed admin sheet for the TB/MBC item.
