We have sent our FAA model to OPG, and they have populated it with their estimates of fees and financing costs. We met with them last Friday morning to discuss, and we are now aligned on methodology and figures, including the recommended option. However, there are still some outstanding issues that may impact fees and financing costs. We are currently assuming that:

- * Debt is AAA rated
- * Lenders have priority access to GA cash flow during the moratorium period
- * Interest cost is paid over the term of the bond
- * Maturity date will align with the FAA
- * Provincial Protection Agreement includes coverage of the subordinated debt

With those assumptions and final approval of the text of the letter we are ready to send.
