Slide #4 - remove item #5. We are absolutely NOT seeking a decision on actions this afternoon.

Slide 15-20 = checking now, but be prepared to return to delivery options from FPC. PO apparently unaware of SoC instruction to our team yesterday. Also, for greater clarity, the reason that the charge remains high for 2,500 kWh customers is because of use - so Tx and line loss charges account for that level of volatility, since we've held dx charge constant in the deepest option?

Slide 25 - green line of 2013 LTEP - please show at 800 kWh consumption - what was published in Achieving Balance, please. Same as what has been shown here for 2010.
