Based on MO's question below asking for an easier to explain answer, below is a revised response. OK to share with MO?

Q3 Is it possible a rate increase would affect the savings that eligible electricity consumers will receive from the FHP? Or will government cover any increases to guarantee they do not rise beyond inflation?

Under Ontario's Fair Hydro Plan (OFHP), a typical residential consumer would see a total bill that increases at inflation. As circumstances vary for different consumers (i.e. consumption profile and distribution rates different area of the province), actual increases could be slightly higher or lower than inflation.

Hi Martin – we find the answer to Q3 a little unclear. Any rate increase applications approved by the OEB would then be adjusted, if needed, at the time of one of the Board's twice annual rate updates to keep any increases within the rate of inflation through the GA smoothing mechanism, correct?

3. **Is it possible a rate increase would affect the savings that eligible electricity consumers will receive they will receive from the FHP? Or will government cover any increases to guarantee they do not rise beyond inflation?**

Only the 8 LDCs designated to receive enhanced RRRP will receive savings on the Delivery line of bills. All other consumers must pay OEB-approved distribution rates ~~for these costs~~. Under Ontario's Fair Hydro Plan (OFHP), the inflationary increases will be calculated based on a typical consumer connected to Toronto Hydro, consuming 750kWh per month. Actual increases will be slightly above or below this level, depending on consumption and LDC.
