Also, in terms of edits to be made in advance of Minister's briefing on Tuesday evening:

- Cover page lacks Cabinet Office format for JEP / signatures
- Slide 7 : first bullet needs context. Should be coupled with a statement about how electricity system is already clean and that focus should go elsewhere. Oil and Natural Gas is home heating as well as transportation / industrial sector. Hangs a bit too much.
- Sections : thinking that we should flip the "Discussion Questions for Cabinet" section with "Consultation & Engagement Process" so that the Cabinet Questions appear first, then the rest of process points, please.
