Cabinet Submission:

Slide 8 = Third bullet – references options 25 / 20 / 18 . Needs edit. Recommended option is 25%

Slide 13 – title : “Option 1” just cut the “Option 1”

Slide 65 = / Directly following after slide 65, so ie. insert a new slide. Basically merge slide 4 and this table to be one major table on all elements though the fiscal plan. Might want to change the title of current slide 65 to “Summary of Recommended Enhancements” and then the new slide becomes a true “Fiscal roll-up”?

Page 2, item #2 : edit “exploring the expansion” to “expanding the powers”

Page 2, item #3 : edit inconsistent with submission. DRC no longer referenced in Cabinet Submission. And Exploring becomes “Lowering the ICI Threshold”

Page 5 Phrase appears to be too dramatic “It is highly likely that there will be a fiscal impact...” this is inconsistent with all the presentations we have received on accounting. So this phrase should probably be edited.

Page 5 : “On March 2nd The Premier will...”

Page 6 : “On February 24th Minister of Energy addressed the Economic Club” (this already happened, I know, attended).

Page 10 : Support for Class B consumers – first paragraph inconsistent with Cabinet Submission. Will need to be re-done.

OPG Deck:

No slide numbers but title is “Increase in generator costs”

Remove the reference to Bruce Nuclear. If OPG wants to they could highlight the risk of Darlington cost overruns. This deck in present form, without that edit, should not be circulated forward. It’s

petty and ill-considered.

Here are my edits to the Deck / Cab Sub. Review of other products ongoing, will share further comments later today.

Slide 5 - missing cost savings for #5 - December 2016 small FIT program rationalization

Slide 6 - remove the bottom two bullets

After Slide 9, before current slide 10 = we used to have a slide that showed the GA over time. \$12 B this year, lowering to \$6-billion in out years. Can we find that slide and insert here, please?

Slide 14 : remove first bullet

Slide 20 : in first bullet spell out SPV (Special Purpose Vehicle)

Slide 23 : confusing since this references DRC and options for Class B but we had pulled this as an option. Needs to redraft a few of these bullets to be more definitive about our Class B approach. Also remind them here of the cost savings from removal of social programs from their bottom line.

Slide 24 : confusing re: 50 kW vs 500 kW. Pick one and re-write this slide to be definitive about a recommended approach.

Slide 46 / 47 = Ugh. Cut this as an option.

Slide 49 = re-do the math / bottom line regarding removal of the IPA/RRRP approach from slides 46/47.

Slide 66 = need help making sure this slide / math is up to date based on all of the above, and previous slides.

Slide 68 = missing cost savings of small FIT rationalization. Same edit as Slide #5 above, please.

Slide 72 : rename as "Support for Tenants"

In that section, be more definitive about asking Housing, Energy and MAG to report back in Spring 2017 with options for renters, please. Might require a slight tweaking of the subsequent slides and an additional text to the minute.
