On RRRP "Blue Box" versus "Orange Box". Total number of customers in each option and general locations. I think they need a better understanding of what is R1. Could we maybe think of some communities within the general vicinity of GTHA. So like a hamlet example. (SNAP)

Hydro One rates are based on the usage density of distribution infrastructure, not community-based. Municipalities served by Hydro One can have customers across all rate classes, and even some municipalities with their own LDC can still have some Hydro One UR and R1 customers within the municipal boundary (ex: Ottawa). Hydro One rate classes are found all across the Province, as indicated by the map attached. We cannot state definitively what areas are each class without customer-specific information from Hydro One. However, a likely example would be the Town of Caledon in Peel Region. While the specific hamlets (Caledon East, Bolton, etc...) are likely class UR, the areas in Caledon between these hamlets would likely be R1 customers. (H1 Customer Data Summary Attached)

Questions unrelated to the deck on "bill presentation". That different utilities have different visual descriptions on their bills. But some things are standard. What is standard / governed by regulations and what things are open to LDC to display as they see fit. Also, what is in our (Ontario Government) wheelhouse versus what does OEB control. (SNAP)

By Regulation, Ontario prescribes the display of charges into the main line items (Electricity, Delivery, Regulatory, Debt Retirement, and 8% Provincial Rebate), as well various pieces of consumer-specific information and messaging on available programs. OEB billing codes focus more on issues such as billing accuracy and frequency, and thus the design of the bill is largely at the discretion of the LDC so long as it complies with the Regulations.
