Overview

- Provides proposed themes for the 2017 Budget and identifies alignment with potential existing funding and new scalable requests in the 17-18 PRRT.
- New funding recommendations reflect assessments completed by CO/MOF/TBS to align upcoming policy priorities and mandate letter commitments.
- Choices remain with respect to prioritization of initiatives and timing of implementation which can be considered through the Budget process

Summary of Key Scalable Opportunities

- Potential investments include the following:
 - 100,000 child care spaces
 - Health at 3% plus some small additional investments
 - Highly Skilled Workforce
 - BGI enhancements supporting transformative technologies
- Does Not Include:
 - Additional capital investments
 - New funding for Developmental Services expansion or significant additional investments in Correctional Services
 - Funding for Ministry pressures

MAKING ONTARIO A MORE AFFORDABLE PLACE TO LIVE

OVERARCHING NARRATIVE

Ontario is taking a balanced approach to make life more affordable for families and businesses now and at the same time build for the kind of future we know families need.

The government is investing in priorities that help people in their everyday lives. This includes helping with people's daily costs and monthly bills, improving convenience and choice, and reassuring people that their child or aging parents will receive the best possible care.

APPROVED INITIATIVES, IMPLEMENTATION BEGINNING or JUST UNDERWAY

- **Electricity Price Mitigation** – 8% rebates for residential, small business and farm electricity bills (began Jan 2017)
- **OSAP Reform** – making the program simpler, integrated and fair for students; average tuition free for students with financial need from families with incomes of \$50,000 or lower and more affordable for middle-class families (beginning September 2017)
- **Drive Clean** – eliminating the \$30 fee for vehicle emissions tests (beginning April 1, 2017)
- **UP Express** – reduced one-way fare from \$19 to \$9 with a PRESTO card (began in March 2016)
- **Community Hubs** – make public services more convenient and accessible (Initial planning began in 2015-16)
- **Childcare spaces** - create approximately 3,400 additional childcare spaces starting in 2016-17 school year
- **Digital Government** – enhancing the delivery of public services through the use of technology (plan being developed for release in 2017)
- **Natural Gas Grant Program** – expanding access to communities that do not currently have service (beginning in Spring 2017)

- **Youth Jobs Strategy** – providing employment and skills development opportunities to youth (began in Fall 2015)
- **Adult Education** – developing a seamless, learner-focused system, building on the recommendations of the Premier's Highly Skilled Workforce Expert panel report released in June 2016.
- **Second Career** – ensuring supports for all eligible clients (announced in the 2016 Budget)
- **Ontario Youth Action Plan** – addressing youth violence and resilience by supporting youth-led grassroots groups (began in 2012, enhanced in 2015) .
- **Strategic Investment Fund** – enhanced and modernized facilities at colleges and universities (began in 2016-17)
- **Major Capacity Expansion** – access to high-quality programs closer to home (Phase I announced in late 2014-15, Phase II announced in 2016-17)

INVESTING IN TOMORROW'S ECONOMY

OVERARCHING NARRATIVE

Ontario is preparing its workforce for the economy of tomorrow by building a highly skilled workforce for technology and knowledge-based jobs. The government is also creating an innovation-driven economy, helping firms scale up into global leadership and modernizing regulations to lower the cost of doing business.

APPROVED INITIATIVES, IMPLEMENTATION BEGINNING or JUST UNDERWAY

- **Business Growth Initiative** – initiatives announced in Fall 2016 include support for the Small Business Innovation Challenge and Scale-Up Vouchers. In addition, the Artificial Intelligence Institute will be announced soon.
- **Going Global** – expanding the province's presence in global markets (work started in 2016, to ramp-up in 2017-18)
- **Project Momentum** - approved support for Honda (beginning in 2017-18)
- **Small Cidery and Small Distillery Support Program** - new program to support small cider and spirits producers to scale up (beginning April 1, 2017)
- **Ontario Microbrewery Strategy** – supports the strength and vibrancy of the industry (began in 2005; extended to 2017-18)
- **Horseracing Partnership Funding** – continuing to provide marketing and responsible gambling support to the industry (began in April 2014; extended to 2021)
- **Green Investment Fund** – an initial investment to reduce GHG emissions by supporting energy-efficiency initiatives and building a network of electric vehicle charging (began in summer 2016)
- **Climate Change Action Plan/Greenhouse Gas Reduction Account Initiatives** – key actions to combat climate change and shift to a low - carbon economy (Action Plan released in June 2016; initiatives to begin implementation in 2017-18)

OVERARCHING NARRATIVE

Ontario continues to make improvements to the health system to deliver high-quality health care that put patients and their families first.

APPROVED INITIATIVES, IMPLEMENTATION BEGINNING or JUST UNDERWAY

- **First Nations Health Action Plan** – access to culturally appropriate and effective health care (began in May 2016)
- **Drug Benefit Program** – reversal of income testing for seniors to maintain affordability of access (began in 2016)
- **Residential hospice and palliative care** – funding 20 more hospices (began in August 2016)
- **Funding shingles immunization** – reducing senior's emergency room visits and hospitalizations (began in December 2016)
- Additional funding for **hospitals, cancer care services, community services** and other priorities (included in ministry base, began in 2016)

- **School Renewal Funding** – an additional \$1.1 billion over two school years (began June 2016)
- **Broadband Services** – access to high-speed connectivity, to support learning needs (began in 2016-17)

OVERARCHING NARRATIVE

The Province continues to invest in transportation infrastructure to help move people and goods and support a competitive economy.

APPROVED INITIATIVES, IMPLEMENTATION BEGINNING or JUST UNDERWAY

- **GO Transit Service Improvement** – \$145M over 5 years starting in 2016-17 for increased rail and bus services across the GO Transit network (began in 2016-17)
- **Connecting Links*** – program expansion (began in 2016-17, annual funding increases from \$20M to \$30M by 2018-19)
- **GO Transit rail service expansion*** – to Kitchener, Niagara and Bowmanville (\$1.7B, [excluding CN bypass], announced June 2016)
- **Integrated GO RER/SmartTrack*** (announced November 2016 [GO RER construction cost \$19.5B])
- **New municipal transit projects*** – including Ottawa Light Rail Transit Phase 2 (\$1.1B, announced June 2016), Region of Waterloo Transit Hub (\$43M, announced June 2016), London Bus Rapid Transit (\$250M, not yet announced)
- **Transportation projects*** – Expansion projects on Highway 401 in Cambridge, Highway 417 in Ottawa, Highway 11/17 between Thunder Bay and Nipigon, Highway 6 between Freelon and Guelph (Morrison bypass); widening County Road 17 in Prescott-Russell (\$889M, announced in 2016 Budget)
- **Remote northern airports improvements*** (\$172M, began in 2016-17)
- **Increase in municipal share of gas tax funding** (beginning in 2019, doubling to approx. \$642M by 2021-22)

OVERARCHING NARRATIVE

To ensure every Ontarian has the opportunity to thrive and participate in their communities, the government is providing supports for families with low-incomes and special needs.

APPROVED INITIATIVES, IMPLEMENTATION BEGINNING or JUST UNDERWAY

- **Ontario Works and ODSP** – increasing rates by at least 1.5% for adults receiving Ontario Works and people with disabilities relying on the Ontario Disability Support Program (began Fall 2016)
- **Basic Income Pilot** – helping inform the path to comprehensive reform (beginning in 2017)
- **Fully exempt child support payments** in determining Social Assistance benefits (began in January 2017)
- **Autism Reform** – increase support to children and youth with Autism (includes multi-year investment announced in the 2016 Budget and the enhanced support announced in Summer 2016)
- **Child Welfare Reform** – more responsive supports (beginning in 2017) and in 2018 raise the age of protection from 16 to 18
- **Long-Term Affordable Housing Strategy (LTAHS)** – Community Homelessness Prevention Initiative, Supportive Housing (both beginning in 2017) and Federal Social Infrastructure Fund (began in 2016)
- **Truth and Reconciliation** – programs and actions focused on reconciliation, co - developed & implemented with Indigenous partners (began in 2016, majority of program delivery starting in 17/18)
- A new **Ontario Anti-Racism Directorate** (established February 2016) and support for the **Refugee Response Coordination efforts** (began in February 2016)
- **Long-Term Strategy to End Violence Against Indigenous Women** (began in 2016)

APPROVED INITIATIVES, IMPLEMENTATION BEGINNING or JUST UNDERWAY

- **Ontario's Strategy to End Human Trafficking** – a survivor-centered approach that strengthens coordination among local authorities, government and community organizations (announced June 2016)
- **Anti-Terror Strategy** - Expansion of policing responsibilities through establishment of Anti-Terror teams within the OPP (announced Budget 2016)
- **First Nations Wage Parity** - Bringing the 9 self-administered First Nations police services to wage parity with First Nations Constables employed under the Ontario First Nations Policing Agreement
- **OPPA and OPSEU (Corrections) Collective Bargaining** – Resources for increased compensation awards
- **Corrections Transformation** – multi-ministry initiatives to modernize the correctional services system (announced December 2016). These include:
 - ✓ MAG - reducing time to trial by appointing 13 more judges and enhancing the bail and remand system.
 - ✓ MCSCS - hiring 239 additional corrections staff to improve conditions of confinement and support.
 - ✓ MOHLTC - strengthening mental health supports throughout the justice process: pre-charge, in-custody and post-release.
