While the report notes that energy prices are increasing in every part of Canada, families in Ontario have seen energy costs increase at a pace consistent with other provinces and at a slower rate than Quebec and most of Atlantic Canada.

Ontario has done the heavy lifting in rebuilding an unreliable electricity grid and transitioned off dirty coal-fired generation. Coal was the cheapest way to create power and the source of smog days and harmful pollution. Getting off coal and upgrading our system means that even though Ontario is already in the middle of the pack of Canadian jurisdictions, we won't see the kind of price increases
