I'll add that Bill 65, the Safer School Zones Act will only be debated for Third Reading if the PCs end their filibuster of the Bill in committee on Monday. To date the PCs have filed over 300 amendments to the Bill and have called recesses to prevent the Bill's timely consideration in committee.
