Hi all, just looping back to recap our next steps coming out of this afternoon's call. John, Jenna and I have discussed.

Communications Strategy

We'll work up two statements to pick and choose from.

1. Statement from Minister(s)
 - Covering openness and transparency of FHP, and clarifying role of public servants in implementing gov't decision.
 - Decision makers can choose which parts they'd like to use, if any.
2. Statement from OPS:
 - Talks about civil service and how they were implementing gov't decision, using language developed for SCOPA appearance.
 - TBC on how this would get used or who would issue it – for now just getting the words on paper.

To supplement existing material, we'll also work up a few Qs to address the new pieces raised in the article. Will use pre-approved language as much as possible. Objective is to arm Ministers for QP and scrums Monday.

We'll aim to share material ahead of tomorrow's call, and use part of the call to collect feedback.

Media Analysis

Here's a high level media analysis as of 5pm – not much has changed since the summary I provided on the call:

- The story is featured prominently on the front page of today's print edition of the Globe & Mail and currently sits at the top of the online version.
- The Globe has tweeted the story five times between 8:30am to 5:00pm today, indicating they are promoting it heavily.
- The article has been re-tweeted close to 200 times via various sources (including the G&M itself and reporters such as Christine Blizzard, David Hains [QP Briefing], and David Reevely [Ottawa Citizen]).
- Key themes on social media include criticism of the Liberal government (using terms such as 'fraud', 'treacherous', 'underhanded'); 'creative accounting', and that the AG has been 'sounding the alarm' on this for some time.
- The article itself has been referenced as an "explosive investigation."
- There have been two mentions of "excessive" FOI fees encountered by David Hains and John Bowker (NDP policy researcher) regarding the Fair Hydro Plan and linking to the Globe and Mail article.
- At this time, there has not been any coverage regarding specific TBS (or other ministry) civil servants.
