Please find attached the draft final agenda (version 3) for the LRC meeting scheduled for December 11, 2017.

I expect potential order changes before publication, so please ensure all ministries are preparing materials with an anticipation of being discussed. As you will have heard, TBC items are ones where there is a potential of not making publication for Dec. 11th LRC so the items may need to track to January.

Few IMPORTANT notes:

- **Heavy Agenda and Meeting End Time:** Given our record-breaking volume (currently 111 items under 35 tabs), there may be a need to extend the meeting 1/2 hour. Once confirmed, this would be communicated through the system next week.
- **PO Support Overdue:** Please do not forget to ensure PO support and let me know.
- **LRC Briefing Notes (due Monday/as early as possible) :** As per usual schedules, notes are due Monday end of day, but early is greatly appreciated to facilitate early publication.
- **Publication (target Monday eod):** To support the members' review I am hoping to publish end of day Monday (would be late night), or at the latest first thing Tuesday morning.
- **REMINDER! 2018 LRC Meetings:** The dates/times for 2018 are now out for ministries to schedule items. Once we come up for air, we will publish the workback calendar for ministries on the intranet site and distribute the CO calendars accordingly. Please note that any items that were removed into the "ether", will not show up on any agendas until the ministries reschedule.
- **Orientation for New Regulation Requirements:** Advisors will need to be aware of new LGIC regulation requirements starting January 1, 2018 coming out of *Reducing Regulatory Costs for Business Act, 2017* and its proposed regulation. An orientation session will be set up in mid-December / early January. Therefore, I am aiming for end of day Monday, if possible, or latest first thing Tuesday. While this doesn't necessarily impact the regular deadline for LRC notes, I would greatly appreciate it if they could come in as they are ready.

Please find attached the first draft agenda for the LRC meeting scheduled for December 11, 2017. This is representative of the items we currently have in MOSAIC.

I would point out that this is a very preliminary agenda, and items are quite fluid, so please do not indicate discussion/non-discussion items to your ministries at this point. Ministries should be preparing all their materials with an anticipation of their items being discussed.

Few IMPORTANT notes:

- **Full Agenda:** There are a lot of items on the agenda (currently are over 105 legal instruments under 44 tabs – would be record breaking). As such, I will ask advisors to please do the following:
 - **Review Need/Rationale:** If an item can wait until January, and especially if it's complex and the instrument is not finished by early next week, it should wait instead of being jammed in. Not looking to provide extensions.
 - **Bundling:** If you have any suggestions to further bundle, please let me know. It would be in everyone's best interest if bundled items come in with **one** approval form.
- **Drafts (past due) & checking readiness:** If you didn't know, ADM drafts were due to CO this past Tuesday November 14th, so please forward them to the LRC team.
 - Draft should include copies of the **current version of the legislative instrument(s)**. This ensures that drafting has already started so ministries and/or CO are not surprised when instruments cannot be ready in time. Leg Counsel has indicated that there may be more regulations tracking that possible to attain, so please make sure your items are realistic in terms of timing.
 - Unless previously discussed/identified, **items that do not have drafts should be removed/rescheduled in MOSAIC to support version 2 of the agenda.**
- **Finals :** Minister signed materials are due by November 30th. As you know, this does not mean ministries need to wait until the deadline, as we at ECO are very happy to receive finals any time before then.
 - For ministries, the work-back deadline schedule is available in the LRC section here: <https://intra.ontario.ca/ops/legislation-and-regulations>
 - This is a very busy agenda, so your help in keeping ministries tracking correctly is much appreciated.
- **Titles & Descriptions:** Your feedback is welcome during the draft stage for both the titles and descriptions.
