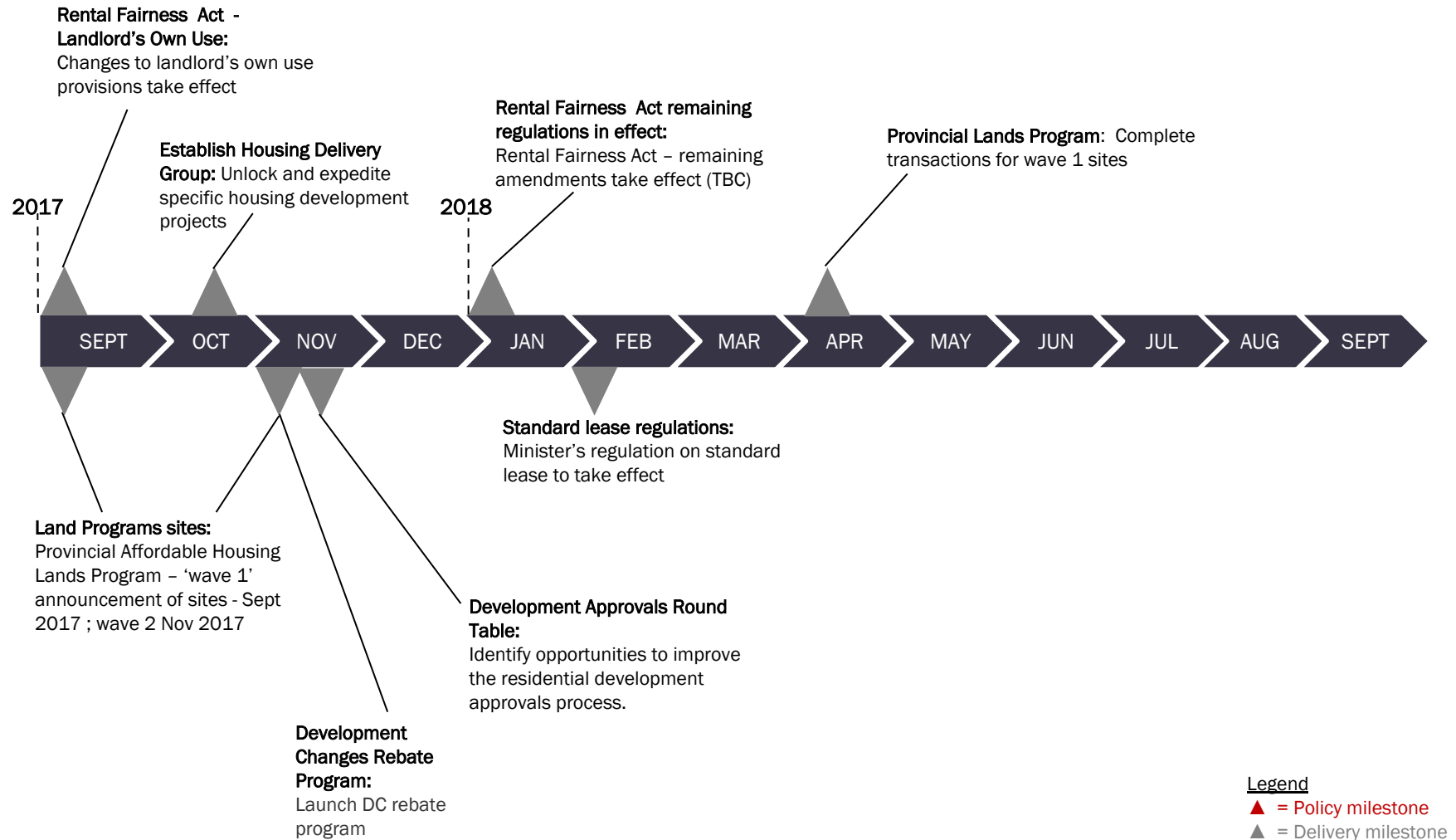

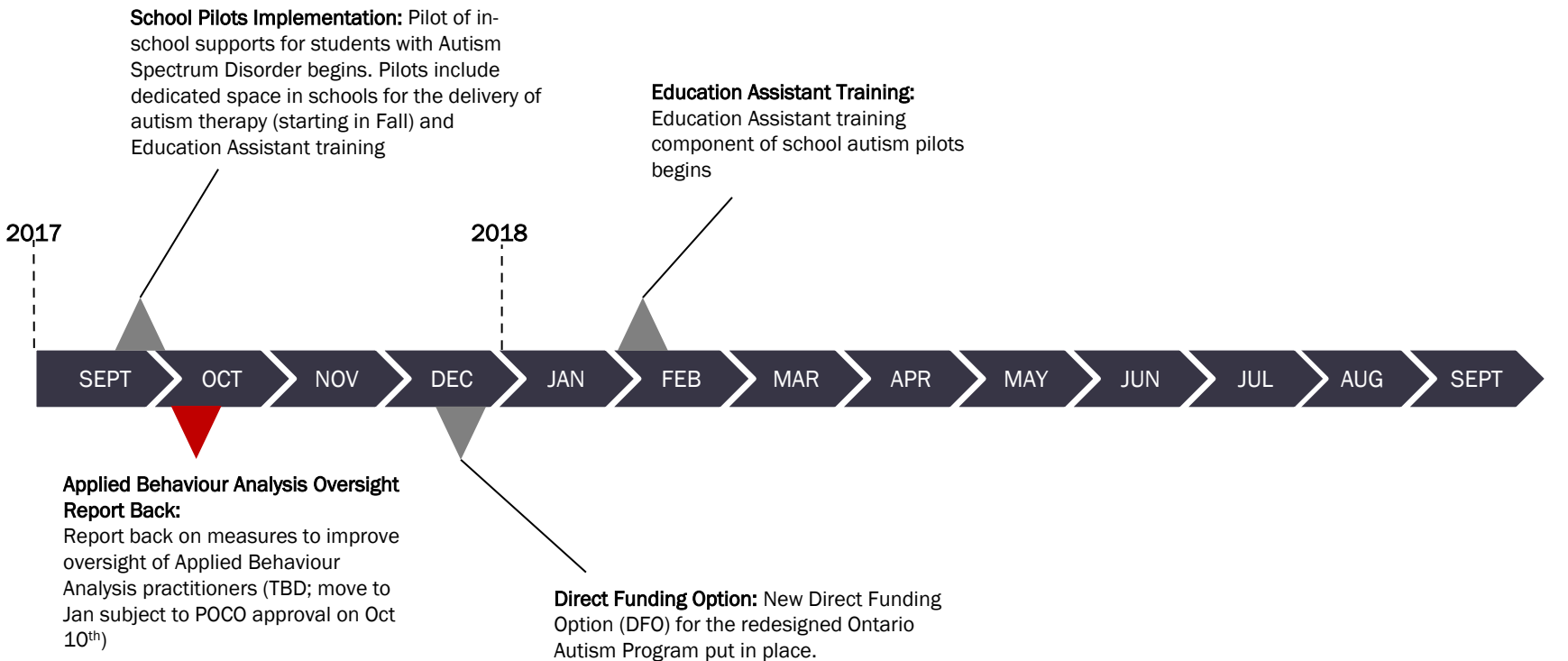

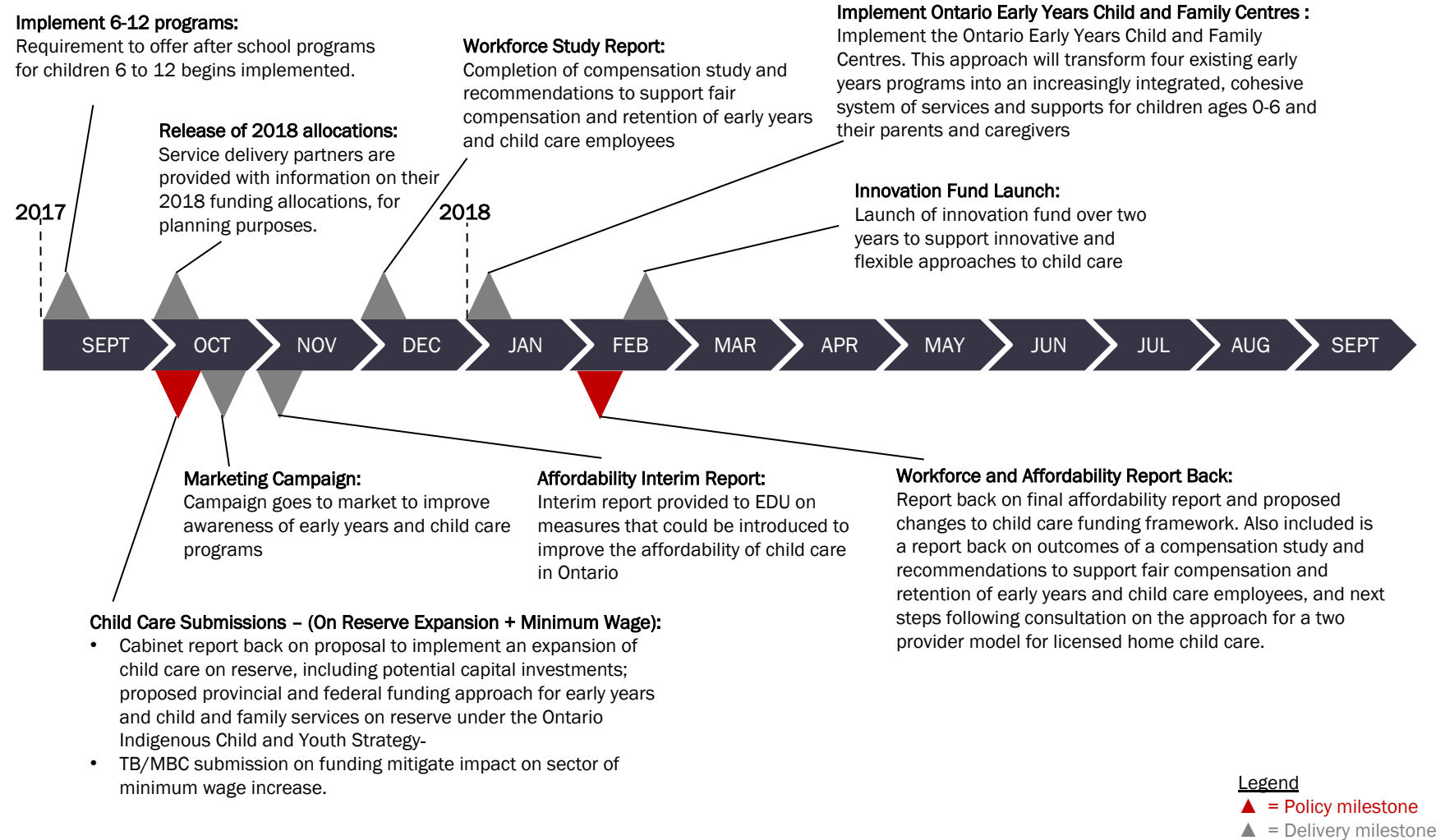

Ontario's Fair Hydro Plan (OFHP)-Global Adjustment (GA) Refinancing Implementation (Sept-Dec 2017)

Implementation of the partial GA refinancing including: Minister of Energy to set Fair Allocation Amount (FAA), OPG/SPV to produce financing plans consistent with FAA, OPG/SPV to begin purchasing investment asset, OPG/SPV working with lenders and credit rating agencies in establishing the vehicles for selling of investment asset interests.

Ontario Electricity Support Program (OESP) Automatic Enrollment of New Social Assistance Recipients:

Implementation of OESP automatic enrollment for new social assistance recipients via SAMS as part of intake. In the interim, new and existing SA clients will be enrolled through a manual process led by a dedicated team at MCSS. This team is responsible for reaching out to over 90,000 existing SA clients that have not enrolled in the OESP as well as processing over 5,000 new grants each month referred from local offices. MCSS will report back to TB/MBC on progress in Fall 2017.



- **LTEP and IESO/OEB Implementation Directives:** Approval of final LTEP document and the implementation directives to the IESO and OEB. The agencies must then submit implementation to the Minister of Energy **by January 31, 2018** for approval.

ON-QC Trade, Storage etc. Report Back:

ENERGY continue to work with the Independent Electricity System Operator (IESO), the Ontario Energy Board (OEB) and appropriate ministries to identify opportunities to remove costs and greenhouse gas (GHG) emissions from the electricity system through efficiencies, other funding sources and supply mix decisions, consistent with government priorities, including ongoing discussions with Hydro Québec, storage providers and other electricity market participants, and report back to Cabinet in 2017.

Introduce legislation to increase consumer protection and support quality new home building by: Introducing greater transparency, accountability and oversight measures for Tarion; making government, not Tarion, the decision maker on the content of the mandatory warranty and new home builder and vendor regulation; creating a new administrative authority to regulate new home builders and vendors and strengthen the regulation of builders and vendors; addressing transition issues to ensure continuity of coverage and stability of the system; and, maintain Tarion as the sole warranty provider.

Loyalty Points

Regulatory amendments to implement 2016's Bill 47, the Protecting Rewards Point Act (Consumer Protection Amendment) to prohibit expiry of loyalty points due to the passage of time alone.

Regulatory amendments under the Consumer Protection Act, to implement 2017's Bill 59 - Putting Consumers First Act to improve consumer protection against high pressure door-to-door solicitation and contracting tactics for certain goods and services.

Consumer Real Estate and Travel

Legislative amendments to Travel Industry Act and Real Estate Business Brokers Act to enhance consumer protections in travel and real estate industries.

The Independent Advisor on Corrections Reform's final report will help inform the government's approach to long-term reform in the corrections system. This work may include exploring options for enhancing programming and formalizing internal and external oversight functions.

Strategy for a Safer Ontario Legislation:

MCSCS to introduce a police omnibus bill, including legislation to repeal and replace the Police Services Act, to implement the Strategy for a Safer Ontario.

Corrections Reform – Health Transformation:

MCSS and MOHLTC to report back to Cabinet in Spring 2018 on longer-term initiatives to transform the delivery of healthcare services in the corrections sector.

Police Oversight Legislation:

MCSCS to introduce a police omnibus bill, including legislation to enhance Ontario's civilian police oversight bodies, which was recommended by Justice Tulloch in the Independent Police Oversight Review.

Corrections Report Back:

Report back with actions to address corrections reform, including an update of transforming the delivery of healthcare services, and informed by both reports by the Independent Advisor on Corrections Reform.

Corrections Legislation:

New legislation to support corrections reform. This will be the first substantive review of existing legislation since the 1990s and will include a legislative definition of segregation based on conditions of confinement and international standards - not on a physical location within an institution.

Ontario Special Investigations Unit Act to come into effect
