Not much feedback to reflect from the meeting with PO. Mike wants this to be more reflective of what cabinet sees as their message/brand than necessarily the items we are internally focused on (to the point he flagged that there was nothing on highly skilled workforce/education). On our specifically he noted transit can't be only about GTHA investments but transit AND transportation (he noted highway 417 in ottawa as example or london lrt) across the province.

As Jay notes, Steven was very crisp bullets, not necessarily full sentences.

For some it may be just as easy as taking from the word document and deleting words but I know it isn't quite that simple.

Hi Everybody,

Attached is the draft PD&G deck, updated to reflect feedback from the DM and PO this afternoon. In order to meet the timelines outlined below, I would ask that your teams focus on populating slides 6-13 and to provide the populated slides to Kelsea and I by **1pm Friday June 9th** so that we can provide an updated and integrated deck to the DMO for 2pm.

For your consideration when reviewing the deck:

- You can change the titles of the rows or to add/delete rows if needed - please flag such changes to us, so that we can update the mapping to the MYAP key activities on the far right column;
- I've made assumptions on slides 11 (Investing in Education and Building a Highly-skilled Workforce) and 12 (Building Transit and Transportation), in particular – the bucketing here deserves particular scrutiny;
- The DM has asked for high-level text in the boxes, rather than sentences;
- For example, Key Considerations should articulate the risks and could include statements such as: high stakeholder sensitivity; additional costs to be determined; focus is on delivery; etc.

Also, as indicated by Ewa below, there is a window tomorrow to make any updates to milestones and risks in the Tracker, so that the updated information can be reflected in the reports produced for PD&G next week. We'll need to do a final check on Monday to ensure that the risk information if the deck is aligned with the information in the Tracker and MYAP.
