Hi Martha,

I know you are eager to study LTEP over the weekend so attached are the latest documents and a brief summary of the state of play. Let me know if you have any questions.

Tracking: Spoke to Hillary and confirmed they are preparing for DTC July 26 (policy initiatives) and again August 31 (modelling). They are discussing TB/MBC and LRC/Cabinet dates internally and will confirm their preference on Monday. They clearly understand the need to go to TB/MBC before releasing the document. We discussed two options:

1. August 16 TB/MBC, fast track August 16 CAB ratification, September 11 LRC/Cabinet (OIC, directives)
2. September 12 TB/MBC, fast track September 13 CAB ratification, September 25 LRC/Cabinet (OIC, directives)

Minute: Draft is with Energy for review and at first glance they are comfortable with the changes we suggested earlier this week. There are items not yet contained in the minute which they are working to add in and will share a revised minute early next week. They will likely remove the details of the directives from the minute and capture them in the policy direction instead (with a minuted report back with the directives along with the Proc OIC).

Deck: We provided some specific suggestions for trimming down the deck, including removing much of the context and background and trimming the 'chapters' to focus on the major decision points. They were taking a similar approach anyway and are working away on a revised deck.

Briefings: Atel indicated that he is working with the PO (!) to set up a further briefing before this goes forward to Cabinet, not clear if this is in addition to the briefing on July 24 or not but Hillary is checking. I suspect it will be. I flagged that we would like to know when they plan to share out materials with partner ministries (including MOECC) and that we would likely set up a briefing for folks next week and share out the pink note by Tuesday at the latest. Will check in with her early Monday to see what their plan is.
