The current PRRS is a full-service, "turnkey", centralized solution provided by a third-party vendor. The contract expires on October 21, 2019 and has no options to extend beyond that date. The Ministry is requesting approval to competitively procure a vendor to provide the Parks Reservation and Registration Services for a ten-year period. The total estimated value of this procurement is \$69.2 million.
