Hi Martin, Hillary,

Coming out of the Premier's briefing this morning there are changes to the LTEP minute. The specific changes are set out below, for your reference, and in the attached (blue highlights are the changes from the P's briefing; yellow are the TBS changes Tim sent over earlier).

The PO will also share these with your MO. We are working towards mailing out materials to Cabinet members this afternoon (1:30pm deadline). Please let us know ASAP of any major concerns with these changes.

Water / Waste water:

2.D.v. Working with MOECC, explore mandating Green Button for water and wastewater facilities and report back to Cabinet with a proposed approach.

Market Renewal:

2.E.x. Working with the IESO to ensure that Market Renewal is consistent with the objectives of the Climate Change Action Plan and is designed to help reduce GHG emissions from the electricity sector.

Outlooks:

5. ENERGY work with MOECC and the IESO to align LTEP outlooks with Ontario's greenhouse gas reduction targets and report back to Cabinet in summer 2017 with modelling outlooks to be included in the 2017 LTEP.

TB/MBC report backs:

7. ENERGY report back to Treasury Board/Management Board of Cabinet prior to the release of LTEP on the program design, implementation plans, and a funding strategy for the Smart Grid Fund.

8. ENERGY report back to Treasury Board/Management Board of Cabinet through the 2018/19 PRRT process on the program design, implementation plans, and a funding strategy for the International Energy Demonstration Fund pilot.
