We have had a chance to review the draft directives and have a few questions and comments for the ministry below. Please let me know when we can expect to see the rest of the LRC package including the approval form and LTEP document related OIC itself.

LTEP IESO Directive

- PO has asked that the directive include some language on Market Renewal and CCAP consistent with the language from the policy minute. Please propose language for review.
- 2.3 Are you able to provide some background on the direction around hydrogen pilot projects? Is this an extrapolation of the item identified in the appendix 1 of Energy's LTEP submission (Slide 61) as an example of "home grown nuclear innovations"?
- 3.3- review of regional planning process- suggest that engagement with Indigenous communities should be included for this in addition to consultation with stakeholders and experts.
- East-west Tie- is further direction not needed in addition to the August 4th letter re updated needs assessment?
- No reference to the direction to stop accepting incentive project applications for behind the meter generation projects using fossil fuel by July 1, 2018. This was specifically called out in the policy minute. Is it being accomplished in some other way?

LTEP OEB Directive

- 2.1 sub bullet 2 re "protection of consumers in the natural gas sector"- Are you able to provide some elaboration as to what the intention of this would be?
