**Thursday 20 July 11.30-1pm | Review of Long Term Energy Plan Final Cabinet Submission**

(Policy Document) = the Cab Sub tracking to 26 July Cabinet.

- *As discussed, we are taking a major crack at turning the 130+page document into a much shorter deck. Each of ENE three divisions have been given a constraint target for their slides. Somewhat appropriately, we are aiming to take 25% off (on average).*

**Wednesday 2 August 1.30-2.30pm | Review of next round LTEP / OFHP Model Assumptions (Pricing Outlooks).**

- *This would be a report back based on this past Thursday's 12.30-pm multicornerers regarding the reconciliation of OFHP with LTEP.*
- *Note that delay in report back on this item has been established to ensure that all possible resources for modeling needs are dedicated to preparing for the Hydro Quebec briefing next Friday, given the timeline sensitivity requested articulated by PO yesterday on that file. This also gives ENE time to focus on the LTEP Cabinet Submission on 26 July and come back with a stronger options item for the week after Cabinet.*
