Please note that OPCD has not yet received the accounting analysis from either IESO or OPG regarding the impact of the regulation that provides for payment from the IESO to OPG for financing costs during the

period from 2017 to 2021. We will need to review and evaluate from a consolidated provincial view once received. I'm not aware of an issue with the structure, but have not yet received the required analysis. I have not added this comment to the note. My edits are primarily related to describing the GA refinancing structure .
