Thank you for sending along additional changes, and following up with ministries on scheduling items. Attached are two products I was hoping to update for distribution early next week:

- Updated version of the **internal LegsRegs planning list for 2018** that was requested by the DM.
 - o Updates items based on scheduling requests and identifies items that are already in MOSAIC and not.
 - o Bucket list on second page is a lot smaller, and hoping to chat/clarify potential tracking within the couple of weeks.

- First page should be items where CO policy has a good idea of the item proceeding and its potential timing. These could be included in MYAP planning calendar for informational purposes only; however, most also need to be scheduled in Evista.
 - o Note: I've included the LRC deadline at the bottom of each column.
 - o Note: If the items are regulations that impact business, there is normally a 45-day posting period on the Regulatory Registry before LRC/Cabinet consideration.
- Second page is a bucket list, with items and/or timing of items still to be confirmed.

Hi Everyone,

Understanding that the time until the possible writ is coming quickly, the Deputy has asked for an overview of the leg/reg landscape from January to April/May. Building on the good work that James is doing with the calendar, I would like to populate the planning calendar with **potential bigger profile 2018 leg/reg items**. This will *not* be ALL items, simply leg, and regulations/OICs that either implement significant policy initiatives or recent government legislation.

There are 6 LRCs before the writ: 1 in January, 2 in February, 2 in March, and 1 in April. Ministries will need to work ahead to ensure that reg registry postings, etc. are done well in advance, as postings would most likely not be allowed after April (and they won't have venues for approval either).

To make your lives easier, I've done some research and kept my keep my eyes/ears open for potential items in MOSAIC, MYAP, in recent policy minutes, leg tracker, and looked through recent leg to see where proclamation is required. So here is my list with portfolio items grouped together, please add/remove/change as appropriate.

Already Scheduled or Confirmed:

January 23, 2018

- MGCS – Elevator Availability (LEG) → *is this even possible given policy track?*
- ENERGY – Fair Hydro: OESP Changes (OIC, REGs)
- MAG – Construction Act Proc (OIC)
- EDU – CYFSA Implementation (REGs) → *is there a bunch or just one?*
- EDU – Reverse Education Tuition Agreements (REG) → *confirming no leg attached to this, per leg tracker?*

February 6, 2018

- MCSCS – Corrections (LEG) → *still to be scheduled in MOSAIC*
- MOL – WSIA/PTSD (LEG) → *still to be scheduled in MOSAIC*

February 20, 2018

- MGCS – EVs in Existing Condos (OIC, REG)

March 5, 2018

- MAG - Construction Act Implementation (REGs)
