Climate Change Mitigation and Low-carbon Economy Act, 2016

Governing the determination of the amount of, and the manner in which, the ministry will issue an order to pay an administrative penalty under for non-compliance with the Act or its regulations; and, enabling the creation of offset credits through outlining the overall process, criteria and administrative requirements involved in the creation of an offset credit that can be used to meet a compliance obligation - (REGs).

Transition for EV Charging Provisions

Building Code Act, 1992

Establishing a transition provision that would exempt compliance from the new electrical vehicle charging provisions for houses and workplaces under development, where specified planning approvals have been previously secured and electrical infrastructure has been substantially planned, financed or completed but where building permit applications have not yet been filed as of January 1, 2018 - (O. Reg. 332/12).

Requiring electricity vendors and unit sub-meter providers to include customer-specific bill messaging showing the exact amount that each consumer has saved through the Ontario Fair Hydro Plan - (O. Regs. 196/17, 195/17).

Freezing the formulas used to apportion costs of mandated services among member municipalities of District Social Services Administration Boards (DSSABs) for 12 months to December 31, 2018, in order to support the DSSAB review that is currently underway and continued access to services for the residents of the District of Cochrane - (O. Reg. 278/98, 367/11, 129/99).
