Hello all, thanks again for your continued support on this file. Your quick and detailed responses are really helpful.

As mentioned in my request for updates last week, we are tracking direct to Cabinet for October 18. This item will also be reviewed at Fiscal Prep Committee next week, on the 11th. Working back from those dates, the plan is to now finalize the submission, in order to deliver materials on Tuesday the 10th in advance of FPC, then signed material on Thursday the 12th. In light of this, attached are three files that we are asking you to review and update. This will likely be the last opportunity to review and finalize before the material is taken forward for Minister signature and delivery to CO.

1) Decision deck

- REQUESTS:
 - 1) Review minutes. We have made some restructuring and simplifying edits to the minutes based on advice from CO, to make the minute higher-level and to allow more flexibility. Please review our suggested edits which are tracked, and either confirm or make further edits as necessary.
 - 2) Review the descriptions of your items in the main deck and appendix. Please ensure consistency of descriptions between the appendix and the main deck, and do a final proof of all content.
 - 3) Confirm DM and MO/Minister alignment on taking the initiatives forward to Cabinet.
- DEADLINE: Friday Oct 6 end of day

2) Abridged deck

- REQUEST: Please review content related to your items and ensure consistency with the decision deck.
- DEADLINE: Friday Oct 6 end of day

3) Status of initiatives summary (decision items only).

- REQUEST: Please review the information for your initiative and update as necessary – CO has asked for an update on the overall 'readiness' of each initiative.
- DEADLINE: 10am Thursday, Oct 5.

I apologize for the short timeframes. If you have questions or concerns please let me know. If necessary we can arrange a call with this group to discuss timing and next steps.

I understand my DMO will pass this along to your DMOs to make them aware of the request and timing.
