I think that the earlier decision to keep Reducing Electricity Costs for Businesses in chapter 2 was that the ICI part was part of the Fair Hydro Plan. As such, I think the part on the ICI expansion at least needs to stay there.

Potentially, the DRC and all the NIER wording in Chapter 2 could go to Chapter 3. If that's the direction, I'd be fine with moving just the NIER and DRC text there.
