I understand PEMD sent some highlevel points up last night, probably including the point that a lot of the options are fiscally expensive

I think a few main questions for us might be

- Risk that "rededicating" the departure tax now, with OEFC will reopen the question around paying for stranded debt
- Same risk might apply regarding option for early end to DRC for some customers
- Risk (if OPCD hasn't previously weighed in on this, which I don't know?) as to whether proposed amortization is consistent with PSAB and with path govt takes regarding rate-regulated accounting
- Risk as to fiscal impact regarding accounting requirements as to how/when to book impact of changes to renewable energy procurements
