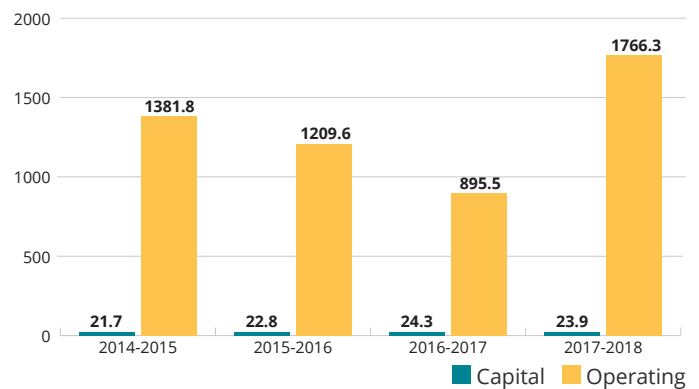

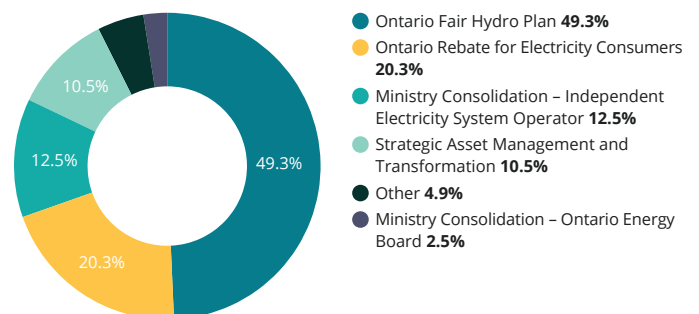

Historical Expenditures (\$M)

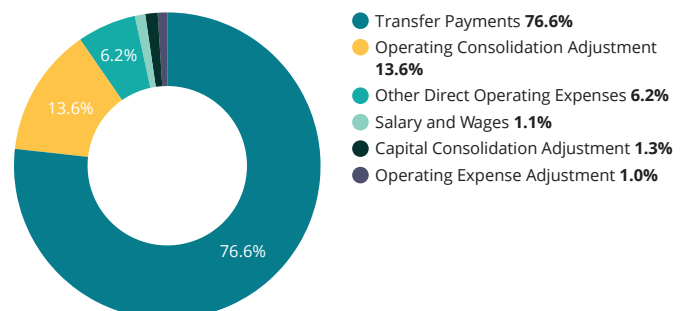


Interim Actuals 2017-2018
