Hello Secretary, Deputies,

Marc attended the CAO forum on my behalf today – below are his notes from the discussion. (Thank you, Marc.)

1. **OPSEU Collective Bargaining Updates – Materials Attached (Marc Rondeau):**

- Provided an update on the upcoming collective bargaining cycle and the proposed approach to conducting consultations with each ministry
- OPSEU Unified and Corrections contracts expire December 31, 2017 (Note: AMAPCEO expires March 31, 2018)
- Initial discussions with OPSEU have begun on bargaining process and negotiations on the essential services agreement will begin first at OPSEU request in July 2017 with issues bargaining to follow (potentially December 2017)
- On March 3rd formal memo will be sent to all CAOs outlining next steps and request Ministry leads to participate in essential services planning
- Centre for Public Sector Labour Relations' (CPSLRC) consultation strategy will consult with ADM level groups (i.e. HR Community) and will be open to all OPS MCP managers for the first time through an Online Survey beginning March 15
- Enterprise report back on consultations is expected end of April to ADM level forums

2. **TBS Update (Karen Hughes):**

- Q3 Report was presented to TB today – overall very close to savings targets – no additional actions recommended to Board
- Public Service Salary Disclosure will be released the last week of

March

- Budget date has not been set – potentially information next week
(Note: Federal Budget date not set yet either)
- \$1.2B savings target is already minuted for 2017-18 as per prior years
(spend to 97% of allocation)

3. Queen's Park Reconstruction Project (David Hallett and Tera Oswald):

- Meetings with early decant participants (TBS, MGCS and MCSS)
continuing next week
- Agreements need to be finalized on planning principles, security,
touch down space, etc.
- Detailed information collection is underway (number of staff, specific
requirements, etc.) – March 31 completion
- Focus groups are underway currently with impacted QP staff and a staff
survey is being finalized
