Subject: Cabinet Office's post Q3 savings

Secretary,

As you know, TBS asked ministries to revisit their Interim Expense Outlook and to and put forward additional savings to support the achievement of the Year-End Savings target. We provided \$600K in Q3. Blair and Marc have worked within Cabinet Office to identify additional savings. There are over \$1.1M in outstanding commitments in Cabinet Office program areas including planned hires, outstanding procurements and planning transfer payments. Of this \$1.1M, we have identified \$104K to offer as additional savings. This includes putting recruitment on hold for a few positions in Communications and Corporate. The Ontario Digital Service has very ambitious plans to hire 5 managers by the end of fiscal. We will be monitoring their progress as delays may result in additional savings. The attached email has the details. Thanks
