Sorry for the slow response.

Staff are working to get our material over to you asap. Hoping to have by end-of-day tomorrow. We had an unexpectedly high claim from Hydro Ottawa in November which has virtually exhausted our accrual fund. I believe we had flagged the OCEB risk for TBS in Q1 and Q2, indicating we may need up to an additional \$20 million and that we would submit an in-year request for appropriation increase if the risk materialized.
