Hi Lawvin, Jack and Christine,

As discussed, to support your prep for tomorrow please find attached a set of QsAs and reactive Minister's statement. I haven't had the statement translated because I wasn't sure if we'd need it – but happy to do so if you think it would help.

We've added the Qs to the end of the existing issue note, which we've also updated now that the story has run, so you have everything in one place.

A couple of points in the Qs are still undergoing Energy fact check, and there will be a couple of additional Energy Qs coming later, which we'll add to the package and send back to you. For now I wanted to get you this given the time.

Also wanted to flag that the AG's IESO audit report was actually posted on the OAGO [website](#) on April 11. It's buried deep on a page dedicated to Standing Committee on Public Accounts (about three quarters down the page). Obviously no fanfare associated with this posting given no one even noticed it. So as far as we know nothing new is being released tomorrow.

Updated: Sunday April 22, 2018 – 4:00pm

- Currently the top story on the Globe & Mail online. The news outlet continues to tweet the story every two hours.
- Over 3,000 social shares.
- The video accompanying the article has had at least 10,000 views.
- At the time of writing, the article has not been shared by the leader of the official opposition nor the leader of the third party.

Related coverage:

- At the time of writing and since the Globe & Mail article was published, there have been no further articles specifically regarding accounting for the Fair Hydro Plan.
- However, articles of related interest include:
 - "[Sorry Howie, you were right about Hydro](#)," Editorial, Toronto Sun, April 22, 2018. This piece is critical of hydro costs and references the Auditor General:
 - "Sound familiar? Kathleen Wynne, the current Premier, has a pre-election plan to temporarily lower hydro bills by 25% by spending \$39.4 billion - an \$18.4 billion loan for the rate reduction itself and \$21 billion in interest down the road. However, after the election electricity rates will again start rising through 2021 and by 2028 ratepayers will pay more than the actual cost of electricity "to pay back the borrowings," Ontario Auditor General Bonnie Lysyk reported in 2017."
 - "[Ontario's 'lost decade' under the Liberals](#)," Lorrie Goldstein, Toronto Sun, April 21, 2018. The focus of this article is the province's debt and cites both the Auditor General and Financial Accountability Officer:
 - "Their average surplus was \$1 billion and that's conceding Wynne's argument her government had a \$642 million surplus in 2017-2018. Both the Auditor General and Financial Accountability Office say this was achieved through accounting tricks and there is actually a \$4 billion to \$4.5 billion deficit in 2017-18."
