Is the OEB announcement part of what the Wynne government announced re hydro price cuts?

Response:

Yes. The RPP rate reductions that take effect on May 1st include a portion of the bill reduction announced in the government's proposed Ontario Fair Hydro Plan.

The government has indicated that it intends to introduce legislation that, if passed, would implement the proposed Fair Hydro Plan starting this summer. The OEB will then further adjust RPP prices as needed so that RPP customers receive the full rate relief as legislated.

Topic : History of Electricity Rates in Ontario

Reporter's Questions:

When was the last time electricity rates went down in Ontario?

Response:

Every six months, on May 1 and November 1, the OEB calculates how much it will cost to supply electricity to customers, and establishes new time-of-use (TOU) rates to recover the costs from customers covered by the Regulated Price Plan (RPP).

RPP prices are designed to ensure consumers pay a stable and predictable price that reflects the costs to supply their electricity over time.

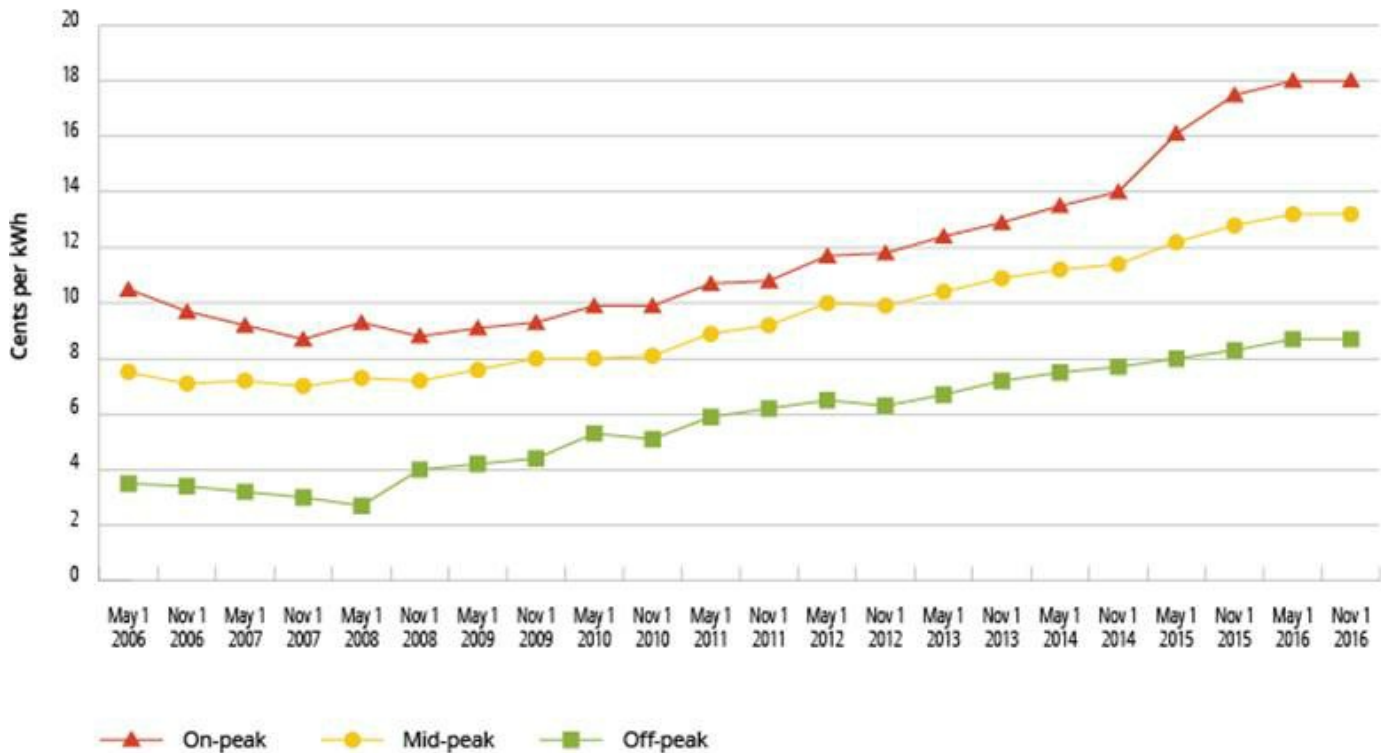
As of May 2017, nearly all residential customers and many small business customers on the RPP pay time-of-use prices. As a result the RPP rate data provides the best indication to response to your question concerning the history of electricity rates in Ontario.

Between May 1, 2006 to Nov 1, 2007, electricity rates showed overall decreases as follows (Because Peak and Off Peak Periods change twice annually it is best to compare Year over Year Figures):

Price in cents/KwH	May 1, 2006	May 1, 2007	Nov 1, 2006	Nov 1 2007
Off-peak	3.5	3.2	3.4	3.0
Mid-peak	7.5	7.2	7.1	7.0
On-peak	10.5	9.2	9.7	8.7

The chart below gives you a visual representation of the changing TOU rates every six months since 2006.
