Hi Andrew,

We spoke briefly following the Minister's Q&A at the OCC's OBAC luncheon. As I mentioned at the luncheon, it's important that we get in touch regarding the engineering solutions to the crisis in electricity rates.

Since his appointment to Cabinet, OSPE has been in the waiting queue for a meeting with the Minister. Recently, both salient and time sensitive conclusions have flowed from our energy policy advisory group, garnering attention from a number of energy stakeholders. This is because we have discovered ratepayer cost savings and economic / environmental benefits in the system that total in the billions of dollars.

Now that I've given you a teaser, can you assist me in escalating OSPE's request to meet?

I recommend that we schedule two meetings:

Our initial meeting should consist of yourself and a selection of policy advisors who meet with me and perhaps one other to briefly discuss OSPE's recommendations at a high, non-technical level. From this meeting I would ask for your team to conduct its own background/audit research and select the viable/preferred items for our second meeting.

Our second meeting should be with yourself, the Minister, the DM, senior political staff/advisors, and MoE policy advisors. From OSPE I will involve our CEO, our President, two of our subject matter experts, and myself. The first half of this meeting will detail the high-level takeaways for the Minister and the second half will be a Q&A/technical discussion on desired items.

Please respond to this proposal at your earliest convenience.

We want to give you and the Minister the benefit of being the first to receive and review our recommendations. OSPE takes very seriously our role as a valued resource to government and a

champion for the public interest.
