Good Morning:

Wanted to circle back, based on the conversations and updates last week regarding the implementation of Ontario Fair Hydro Plan (OFHP).

10 April | LRC

- OESP Regulatory Change
- ICI Regulatory Change

N/B: Both of these are administrative amendments to ensure LDCs have the runway to enact the changes announced. Also, a DM's variance memo will come over to CO on the ICI because technically the NAICS codes listed in the cabinet submission don't capture greenhouses. OMAFRA apparently confirmed to greenhouse sector that they WOULD be eligible, and we don't foresee many being small enough to be captured (most would have been green light during SFT expansion round last fall), but to avoid an altercation, we are going to propose this slight adjustment. Small pool and technical omission, want to avoid a "policy approval" discussion and just go with variance memo from DM.

1 May | TB/MBC & LRC

This is the big one.

LRC already set to meet at 1-pm that afternoon. Propose TB/MBC be convened immediately prior to that for a report in on Energy items related to OFHP. The Cabinet submission littered with TB report backs. We are tracking to have all ready for that same appearance and then TB/MBC bleeds into LRC. On scheduling, wonder if we just invite LRC members to the TB/MBC meeting, start the whole thing at noon (would make LRC discussion shorter and less of a repetition, I wager, but that's someone else's call).

Goal for TB/MBC & LRC:

- TB Report Back from the February 2017 OFHP Cabinet Minute
- Accounting Opinions = OPG's E&Y and IESO's KPMG
- Legal Opinions = Hogg on Constitutional Question
- Legislative Approvals for "Ontario Fair Hydro Plan Act, 2017"

Report in to Cabinet on 3 May (Wednesday), tentative Introduction date via GHLO Thursday 4 May.

Each of your staff were represented / briefed at our Friday afternoon "OFHP Implementation Working Group", so I think I'm at risk of repetition, but given how busy everyone is with pre-budget, etc., thought it wise to send along this re-cap.
