Good Afternoon:

This should be made to be a bit more robust, by way of additional context & content:

- Cost savings relative to 2013 LTEP by continued operations
- Also, if I recall, this has been built into the OFHP curves, so if continued operations are not pursued then additional rate pressures materialize in the short term as a result?
- Net income calculus from OPG to the fiscal plan
- CO2 impact b/c of less natural gas burn during refurbishments – I think I recall we had a slide on this in the Cabinet Submission on Pickering?
- Jobs impacts / collective agreements – recall that continued operations has a significant collective agreement impact that was part of the Asset Council undertaking a few years back
