Good Afternoon:

As discussed late last week, PO Policy preference appears to align with 26 October, 2017 LTEP Release (Gill / Mike / Philip = please correct me if I am mis-quoting you?).

To that end, please find enclosed a quick deck Ministry of Energy had prepared that broadly lines up with that rollout plan.

Note that they think we should be sending invites to stakeholders for technical briefing about a week prior to the release date, since many (FN, etc.) will need to make arrangements to travel from outside the GTHA.

Also, note that they don't have enclosed the plan to brief Government Caucus on Tuesday 24 October. IF you are in concurrence with this plan then our office will coordinate with Carol Price / Caucus Chair MPP Rinaldi in the weeks ahead.

Finally, please note that all of the above is contingent on "Gravity" (the creative / layout and design firm) is able to accommodate the changes to LTEP design [ie. including the price table in the text as opposed to appendix of main document, as discussed mid-last week]. Early indications at end of day Friday were positive, but we will have to wait until mid-this week to get final word on timing.

For your use and review, a FINAL FINAL copy of the LTEP was printed and delivered to folks on the CO/PO distribution list (per SoC protocols) at end of day Friday. This included our ideal placement of the aforementioned table, and all minor edits that came through via the typo / copy-editing / drafting process.
