Good Afternoon:

MPP Correspondence Edits:

First Paragraph, use the name of the legislation, not just the "legislation to implement"

4th paragraph and the ensuing three sub-bullets can be cut.

Add in the full table of OEB rates that was from April 20 Backgrounder as well as what we have used in the Caucus deck. Just recreate it as an MS Word "table" so it looks good. Feel free to add a citation / source : "Ontario Energy Board Backgrounder, 20 April, 2017" or something, if required.

When returning to the current text, then the OEB acronym will need to be spelled out since in the 4th paragraph deletion the first use will have been cut.

In that "upon Royal Assent" paragraph, add "small businesses and farms" to that line as well, please.

In the wrap up, use the name of the legislation again. Look forward to debate on the Fair Hydro Act, (?) the name used will need to be the name of the omnibus bill, not just schedule 1.

For the Correspondence to LDC CEO's :

"In your June billing." (Hangs.) Should read "June billing period" or something.

---
