David – I have heard back from Energy. This reporter did request an interview with DM Imbrogno – and they have declined. However, in conjunction with their MO they are answering some questions for this reporter – and are in the process of getting approved responses now – and those responses will be emailed back to the reporter.

After we spoke, I did check Public Accounts and yes, Scott Thompson's name is there along with Helen Angus and Cindy Veinot.

Therefore, my recommendation would be to get back to him saying something like this:

Hi Matt –

~~Yes,~~ Deputy Minister Thompson 's-signs a Statement of Responsibility as part of the ~~name is on the~~ Public Accounts process, along with Helen Angus (Deputy Minister of Treasury Board) and Cindy Veinot (Provincial Controller).

He signs off solely in his capacity as the Deputy Minister of the Ministry of Finance to provide reasonable assurance that transactions recorded in the Consolidated Financial Statements are within statutory authority, assets are properly safeguarded and reliable financial information is available for preparation of the Consolidated Financial Statements, from the Ministry of Finance perspective.

~~However,~~ As I said in my previous email, the Public Accounts are overseen by Treasury Board and the Fair Hydro Plan is overseen by the Ministry of Energy . Therefore if you have any further questions about Public Accounts or the Fair Hydro Plan , we would respectfully request that you contact ~~that~~ those ministries
