Attached is a draft analysis. Apologies for the timing, and it is subject to getting feedback from you as well as Ken, who has not inputted into this, as the drafting took longer than anticipated.

It tries to set out the differences in policy intent and context between the proposed FHP and the 1999 electricity sector restructuring that led to the creation of the DRC. There's a lot of historical detail on the latter, which might be more than is needed for some audiences. A pared down version could be provided for other audiences.

Feedback would be very welcome, as you two would have a different perspective to add to that of policy staff at this end.

Please do not circulate further to IESO and Energy at this point, as I'd like to get refine with your suggestions first.
