Hi Marilyn-

We've received an urgent request from CO. They're pulling together their annual backgrounder for regulations, statutes and fees coming into effect on July 1, 2017. Does TBS have any to add? I need to know by end of day please.

Attached you'll find charts [provided by CO](#) that outline **some** of the regulations, statutes and fees for July 1. This list is not exhaustive (i.e. minister's regulations are not captured, items currently tracking to LRC before July 1 are not captured, etc.).

We need to

- identify **all TBS** items coming into effect on July 1, 2017, and populate the attached template with the results. The template includes samples of the type of information **CO** needs for drafting the backgrounder.

- include items going to LRC in May/June. You will have the opportunity to fact-check the backgrounder, so any items that may have dropped off can be deleted at that time.
